*Training: Fred got recertified for another three years, Fred and I went to four NYSTWW conferences, I took OSHA training in Hammondsport and Two AWWA small water system trainings.

Reports: DEC Water Withdrawal Report, Annual Water Quality Report, 12 Monthly Water Reports to the NYS DOH *Hydrants: Flushed all hydrants once, flushed dead end hydrants three times and replaced one hydrant *Grants: Worked with RCAP on customer income surveys needed for grant funding and trying to straighten out Water District Parcels, Applied for Susquehanna River Basin Commission for the Consumptive Use Mitigation – Grant *Meters: Read meters ten times, installed 88 new Neptune meters and registers, replaced six old Badger meters with rebuilt Badger meters. Jeanette and I worked on creating 88 new accounts for billing the new Neptune meters Curb Boxes: We replaced 9 broken curb boxes and repaired 12, Fred and I located and recorded all 271 curb boxes in the system.

*Customer Information: I created a digital account for every customer with curb box location pictures, parcel number, meter and register numbers, service comments and account information.

*Water Samples: We took 12 monthly Coli/E.coli water samples to the Life Science Wayland Lab, we also took samples for 1,4-Dioxane, Iron, Manganese, Nitrates, TTHM, HAA5, Primary Inorganic Chemicals and Synthetic Organic Chemicals. (Approximately 55 different sample bottles)

*Water Usage: We produced and treated 12,938,381 gallons of water, we used 410 gallons of chlorine, we produced an average of 35,459 gallons per day, we sold 375,155 gallons in bulk sales and metered out 9,670,692 gallons to customers. We found 14 customer leaks by using the meter software.

SUPERVISOR

12/19/23 Jim Baase (CEO) of Empire contacted me to inform me that Empire had closed on two of the Air-Flo buildings. This along with the new building they are constructing on Rt.74 will undoubtedly contribute to Prattsburgh both in local employment and economic growth.

12/21/23 A couple of days ago there was a Public Service Commission decision that denied a request by about 80 renewable energy projects, including Prattsburgh Wind (Terra-Gen), to provide an inflation adjustment to their renewable energy certificate (REC) contract with NYSERDA, which provides a source of important revenue for the project. As a result of the PSC decision, NYSERDA has issued a Request for Proposals (a reverse auction) for RECs related to these projects and the project developers have the choice of either proceeding with their current REC contracts or cancelling the REC contracts (and paying a substantial cancellation charge), and rebidding. Terra-Gen has decided to pay cancellation charge and rebid the project. There is an auction once a year. NYSERDA will decide who wins the bids based on the price per megawatt and the number of megawatts the state is planning on purchasing this year.

12/28/23 I worked with Brad Sick (Larson Design) on the application for the SRBC (Susquehanna River Basin Commission) grant. We hope to submit the first week in January 2024. If we are successful, the grant will pay for the remaining 260 plus water meters, meter pits, and other hardware for the water department.

1/2/24 Brad Sick (Larson Design) and I are gathering support letters from Catherine Rees (RECAP) and J.C. Smith (IDA) for our grant application to Susquehanna River Basin Commission (SRBC) to purchase water meters, meter pits, and miscellaneous hardware for the water department. I hope to submit the grant application this week. The deadline is 1/31/24.

1/3/24 The Planning Board and our engineer (Brad Sick) from Larson Design met to discuss the Dinehart Solar Project with the representative from Tract Engineering (Tim Gorley). The Planning Board requested additional information regarding the project. Assuming that is done, on February 7th the Planning Board will review parts 2 &3 of the S.E.Q.R. After that the paperwork is submitted to the county. If all that goes as planned there will be a public hearing on March 20th.

1/10/24 J. C. Smith (I.D.A.), Ed Brockman, and I met to discuss the process going forward for establishing the Sewer District. We are very close to having the grant money to make the sewer district a reality. Hopefully in the next couple of months we will be awarded at least one of the two we applied.

1/10/24 Ed Brockman, Angela, and I had a phone conference with Dwight Kanyuck (Knauf-Shaw) to discuss a plan to address the Terra-Gen project and the fact that the state has basically ignored all the town's laws. This is a standard

process to present a document to a judge on behalf of the town. The process is paid with LAAF funds provided to every town from NYSERDA for representation.

1/16/24 we received a preliminary eligibility determination/funding estimate from Rural Development for a grant we applied. This document makes Prattsburgh's water department eligible under the Water and Environmental Program (WEP) for a grant and loan for phase IV construction. If we secure this, we will be able to apply for additional grants from Water Infrastructure Improvement Act (WIIA) and Community Development Block Grant (CDBG), both of which need co-funding.

Establishing Policy for Employee Contributions to Premiums for Health Insurance Coverage (other than pursuant to a Collective Bargaining Agreement) Motion by Councilperson Einwachter, seconded by Councilperson Scheid to adopt the following resolution:

WHEREAS, the Town Board has established a program by which health insurance is made available to Town employees including contributions by the employees to the cost of the premiums for that health insurance; and

WHEREAS, there are several health insurance coverage plans available to the Town employees as established by the Town Board; and

WHEREAS, it is the intent hereof to establish a policy for the amount of contributions to be provided by the employees toward the payment of premiums for such health insurance plan; and

WHEREAS, the Town Board intends to address any SEQRA issues related to the action; and

WHEREAS, the Town Board intends to further address full-time and part-time employee status as pertains to health insurance.

NOW THEREFORE BE IT RESOLVED, THAT

1. The Town Board of the Town of Prattsburgh designates itself as "Lead Agency" with respect to SEQR issues related to this action and finds that the action does not create any detrimental environmental impacts. Therefore, the Town Board declares this to be a "Type II" action and accordingly no SEQR review of this action will be necessitated.

2. The Town Board, as the employer, hereby establishes a policy to pay 70% of the cost of the premiums for the employee's choice of medical insurance coverage and the employee shall pay the remaining 30% of the cost of the premium for the employee's choice of medical insurance coverage for either a single person medical insurance plan or a two-person medical insurance plan. With respect to family plan medical insurance coverage, the employee shall pay 30% of the cost of premium for an equivalent medical insurance plan for single or two person coverage and, in addition, shall pay the entire amount of the difference in cost between the premium for a single or two person medical insurance plan and the cost of the premium for family medical insurance plan coverage.

3. In the event that the employee is subject a collective bargaining agreement (CBA)

any provision of the CBA pertaining to medical insurance shall control the portions of medical insurance premiums paid by the employee and supersede this policy.

4. The Town Board hereby establishes the policy that in order to be considered as "full-time" the employee must hold a work position defined as thirty-two (32) hours or more per week. Part-time employees are those holding a work position defined as less than thirty-two (32) hours per week. This policy excludes elective offices.

5. It is further established by the Town Board as a policy that the Town shall not contribute toward health insurance premiums for part-time employees of the Town of Prattsburgh.

This policy shall become effective as of February 1 2024.

Resolution recognizing proposed improvements to the Town of Prattsburgh water system to be Type II action for SEQR purposes.

WHEREAS, the Town of Prattsburgh administers the water system serving the Town; and

WHEREAS, the Town has considered the condition of the water supply and distribution system currently in use and has identified improvements necessary for proper operation of the public water supply system; and

WHEREAS, a project is proposed to replace various sections of water distribution infrastructure through the Town and make various improvements to the existing well house and water storage tank; and

WHEREAS, this project is more fully described in the June 2023 Phase IV Water System Improvements Project Preliminary Engineering Report prepared by Larson Design Group, a professional engineering consulting firm; and

WHEREAS, these improvements will correct significant issues related to safe and efficient operation of the facilities; and WHEREAS, the Town Board recognizes the need to complete SEQR proceedings for this project; and

WHEREAS, 6 NYCRR Section 617.5 (Title 6 of the New York Code of Rules and Regulations) under the State Environmental Quality Review Act (SEQR) provides that certain actions identified in subdivision (c) of that section are not subject to environmental review under the Environmental Conservation Law;

"(2) replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building, energy, or fire codes unless such action meets or exceeds any of the thresholds in section 617.4 of this Part; "

"(6) street openings and right-of-way openings for the purpose of repair or maintenance of existing utility facilities," and "(13) extension of utility distribution facilities, including gas, electric, telephone, cable, water and sewer connections to render service in approved subdivisions or in connection with any action on this list."

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF PRATTSBURGH THAT the proposed water system improvements project is declared to be a Type II action for State Environmental Quality Review Act purposes, and no further action will be required.
