I have met with the county about the Lyons hollow bridge project, it is stated to start around May 27th, 2019, I have also met with Jim Rizzely from the county about seasonal walker, the curve is marked out and they will install signage and delineator posts, it will cost approximately \$1000.00. T-304 is back

from valley fab, I have gotten in a load of sluice pipes and we will start cleaning ditches in the near future.

Supervisor McConnell and Fred will be working on the water department increases and getting code info from other towns, the adult league will be doing some repairs to the dugouts and fence on the little league fields, Ed Brockman is still working on the title for the church property

Declaring Repair of Highway Department Trailer as an Emergency

Motion by Councilperson Scheid, seconded by Councilperson Underhill to adopt the

Following resolution:

WHEREAS, the Town of Prattsburgh maintains a Highway Department for the maintenance of Town Highways; and

WHEREAS, for the purpose of the maintenance of such Town Highways by Highway Department personnel, the Town owns various pieces of apparatus, equipment and trucks, including a trailer on which to transport Highway Department equipment to the various work sites throughout the Town for highway, maintenance; and

WHEREAS, that transport trailer requires repairs in order for it to be used for transporting equipment; and

WHEREAS, the Town has several "seasonal use" highways which, pursuant to Highway Law §205-a, are not maintained from December 1st to April 1st each year; and

WHEREAS, without the availability of that transport trailer the conditioning of those "seasonal use" highways cannot be performed in a timely manner; and

WHEREAS, normally it would be required pursuant to the Town's procurement policy to obtain several quotes before choosing the lowest responsible quote; and

WHEREAS, Superintendent of Highways, John Perry sought quotes in the area of Prattsburgh for repair of the trailer but was able to obtain only one quote; and

WHEREAS, Town Superintendent of Highways Perry, in order to carry out the necessary conditioning of the "seasonal use" highways at the conclusion of the winter season has undertaken the immediate repair of the trailer from the one firm that supplied a quote for the repair.

THEREFORE BE IT RESOLVED, THAT:

The repair of the Highway Department trailer is deemed to have been an emergency situation, the one quote received is deemed to be a "sole source"; therefore the Procurement Policy requirements are retroactively waived, the contracting for the repair of the trailer by Superintendent of Highways Perry is hereby ratified and affirmed and the payment of the cost for such trailer repair is approved.
