Put 480 tons of gravel on the hill on Gray road. Ditched Hubbard road, some of Block and some of Mattoon. Put in sluice on Blodgett, Hotckin, Cayward, Hubbard and Cook-School Road. Going around the second time grading bad spots/hills.

Hauled in bank run to stock pile, built and berm to hold water on Tuttle road. Mowing roadsides (final time around) bought a load of sluice pipes. Bought 100 tons of salt middle of October I am planning to switch back and get ready for winter.
