SUPERVISOR

6/17/26 A few weeks ago I had requested a time extension for the ESD (Empire State Development) Grant. ESD has granted a one-year extension to June of 2027. The project does not have to be completed in June of 2027, but has to be well under way.

6/25/26 Beth and I met with the first of two students that vandalized the Rotary Park. The unfortunate situation was handled very well by the mother and son. They have agreed to pay half of the cost to repair the damage. This solution will keep the incident as a civil matter as opposed to a criminal matter.

6/26/26 I received an email from the regional representative of the EDA out of Chicago. The EDA is the organization that has DE obligated one of the waste water grants. She requested a phone meeting ASAP. We set the time for 3:00 P.M. on the 26th. During our phone conversation which was over an hour we discussed the project in detail. There were a number answers in the application that were misinterpreted or misunderstood. At the conclusion of our conversation, she asked me to call her directly as the engineering of the project moves forward. She made it clear that she was making no promises but that she would discuss Prattsburgh's project with her superior to see if they had any monies that could be used in our project.

7/2/26 Larson Engineering completed the filtration and perk tests on the "green space". For the perk test seventeen holes were dug each being twenty-four inches deep approximately two holes for every 1000 square feet. Every hole passed the test with flying colors. I would like to thank John Perry and the highway department for digging of some of the test holes. I would like to thank Chris Underhill for taking the time to schedule inspections of the plumbing in the buildings included in the waste water district. Chris also worked with Larson's staff while the filtration and perk testing took place. At Chris's request Empire donated a smaller excavator and operator to dig test holes.

7/2/26 Mark Bristol, Angela Einwachter, Chris Costanza, and I met to work on a path forward for the main street project. For the most part we looked to the future without dwelling on the past. In conclusion, Chris is going to provide to the town for review a document listing his expectations to move forward.

7/13/26 We were notified late last week that the Town of Prattsburgh would be going through a full audit by a group of four people from the New York State Comptroller's Office. Today four people from the state were on site to begin the audit. It was explained to us that the Comptroller's Office has been focused on schools for the last number of years and now they have switched their attention to municipalities. Prattsburgh was chosen simply because it has been decades since the last audit.

RESOLUTION ADOPTING A GENDER-BASED VIOLENCE AND THE WORKPLACE POLICY

WHEREAS, the Town Board of the Town of Prattsburgh recognizes its responsibility to provide a safe, respectful, and supportive workplace for all Town employees, elected officials, volunteers, interns, and other individuals performing work on behalf of the Town; and

WHEREAS, the New York State Office for the Prevention of Domestic Violence (OPDV) has developed a model Gender-Based Violence and the Workplace Policy to assist public employers in responding to incidents of gender-based violence in a survivor-centered, trauma-informed, and culturally responsive manner; and

WHEREAS, the Town Board finds that adoption of such policy will promote workplace safety, protect employees from discrimination and retaliation, provide appropriate workplace accommodations where permitted by law, and ensure compliance with applicable provisions of the New York State Human Rights Law, Labor Law, and other applicable statutes; and

WHEREAS, the Town Board has reviewed the proposed **Town of Prattsburgh Gender-Based Violence and the Workplace Policy** and finds it to be in the best interests of the Town and its employees;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Prattsburgh hereby adopts the **Town of Prattsburgh Gender-Based Violence and the Workplace Policy**, attached hereto and incorporated herein by reference, to become effective immediately upon adoption; and

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby authorized and directed to administer and implement this policy, including the designation of appropriate personnel to carry out the responsibilities assigned to Human Resources and/or the Gender-Based Violence Liaison (GBVL), as applicable to the organizational structure of the Town; and

BE IT FURTHER RESOLVED, that the Town Supervisor and Town Clerk are authorized to make such non-substantive administrative corrections to the policy as may be necessary, including updating statutory citations, correcting typographical errors, and replacing references to positions or offices to accurately reflect the Town's organizational structure, provided such changes do not alter the intent or substance of the policy; and

BE IT FURTHER RESOLVED that the Town Clerk shall maintain the adopted policy as an official policy of the Town and shall provide copies to Town employees as required by law and the policy itself.

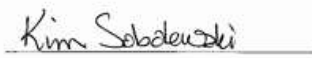

WHEREAS, the Town of Prattsburgh proposes the creation of a sewer district in the downtown commercial area of the Town of Prattsburgh, and

WHEREAS, the proposed project is outlined in the Preliminary Engineering Report and subsequent Map, Plan and Report documents from Larson Design Group (LDG) Engineers has been prepared with respect to formation and construction of the proposed sewer district, and previously adopted by the Town Board, and

WHEREAS, NYS Environmental Facilities Corporation is offering grants for clean and drinking water projects during the 2026-2027 state fiscal year to selected municipalities with infrastructure projects that protect public health and/or improve water quality; and

WHEREAS, the Town of Prattsburgh is seeking funding through the NYS Water Infrastructure Improvement (WIIA) Grant);

WHEREAS, NYS Environmental Facilities Corporation requires a resolution authorizing the undertaking of the project and the total funding appropriated for the project. The resolution must also designate a representative of the applicant who is authorized to sign the funding agreement with EFC and any associated documents.

NOW THEREFORE, IT IS RESOLVED that the Town Board authorizes the undertaking of the project and the estimated project cost is \$2,086,000; and it is

NOW, THEREFORE, BE IT RESOLVED, That The Supervisor on behalf of the (County) (Town) (Village) of Prattsburgh of New York State hereby is authorized to participate in cooperative bidding conducted by The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties for supply of electricity and if requested to furnish The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties an estimated minimum number of units that will be purchased by The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties.
