HIGHWAY (JOHN)

Since my last report we have oiled and stoned Pulteney Tone Line, Presler, Williams, McMichael, Baker, Davis, Waldo, Muck, Bean Station, Butts, Fairgrounds, and lower Cayward. Adding up to just under 9 miles. Cold paving is also completed doing 2 tenths of a mile on Hotchkiss, and 6 tenths of a mile on lower Rosey Hill. All was done with shared services with Pulteney, Urbana, and the county. In between we have graded Early, Hotchkin, Snyder, Edwards, Symonds, Ring Rosé, Gay, Burk, Block, and upper cook, the have replaced or installed 8 sluice pipes. Heavy downpours caused washouts on Rolson, Mattoon, Walker, and Monkey Run, which all had to be addressed. The flail mower is finally up and running, the men have made it around for the first time and are starting another round. No major breakdowns this month.
