RESOLUTION #2

An application has been duly made to the Board of the Town of Prattsburgh, County of Steuben, New York, by Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications, Inc. ("Charter"), a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 6005 Fair Lakes Rd, East Syracuse, NY 13057, for the approval of a renewal agreement for Charter's cable television franchise for fifteen (15) years commencing with the date of approval by the Public Service Commission.

The franchise renewal agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings.

A public hearing was held in the Town of Prattsburgh, New York on February 17, 2025 at 6 P.M. and notice of the hearing was published in the Corning Leader on February 7, 2025.

NOW, THEREFORE, the Board of the Town of Prattsburgh finds that:

- 1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. Spectrum Northeast, LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 3. Spectrum Northeast, LLC can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED that the Board of the Town of Prattsburgh hereby grants the cable television franchise of Spectrum Northeast, LLC and the Town of Prattsburgh for fifteen (15) years commencing with the date of approval by the Public Service Commission and expiring fifteen (15) years hence.

BE IT FURTHER RESOLVED that the Board of the Town of Prattsburgh hereby confirms acceptance of this franchise renewal agreement.

The foregoing having received an AYE vote was thereby declared adopted.

SUPERVISOR

1/14/25 John Perry and I had our weekly meeting with F.E.M.A. to complete the initial review of the roads that were damaged by Tropical Storm Deb. We have completed the first phase of the reimbursement process which consists of documenting every road, culvert, pipe and G.P.S. coordinates.

1/14/25 Angela Einwachter, Matt Bull (I.D.A.), and I had an introductory zoom meeting with Carly Creed-Herman to discuss the next steps and a strategy for the E.S.D. Grant that we were awarded a couple of weeks ago. After a discussion with Jamie Johnson (I.D.A.) my understanding is that Prattsburgh will be assigned a grant director from the state.

1/15/24 I met with Judy Hall (Cohocton Supervisor) and two people representing Delaware Solar. They presented a business plan to build an eight-megawatt project on the border of Prattsburgh and Cohocton. Both parcels are approximately 54 acres. Judy and I requested prints and a projected timeline.

1/17/25 Jamie Johnson contacted me regarding the Terra-Gen Project. The I.D.A has received the application for the PILOT. The I.D.A. will review and probably pass a resolution and set a public hearing at their meeting on the 23rd. After those steps are taken it will be 5-6 months for a final decision.

1/21/24 John and I had our weekly meeting with F.E.M.A. Along with filling out more documents we discussed grouping the damaged roads into groups and getting reimbursement for that particular group of roads when they are completed. I explained to F.E.M.A. that a number of reimbursements through completion of the repairs is the only way Prattsburgh can afford to do the repairs and mitigate for the future.

1/23/24 Dwight Kanyuck (Knauf-Shaw) our attorney handling the Terra-Gen Project gave me a call to inform me that he has received an updated Host Community Agreement (HCA) from Terra-Gen's lawyers. The board will review and then schedule Dwight to meet with us to answer questions and concerns.

1/28/25 John Perry and I had our weekly meeting with F.E.M.A. to start arranging the damaged roads into groups to hopefully be approved for reimbursement as we complete that group. After the repairs for the first group is reimbursed, we will have the money to finish the second group and so on.

2/4/25 John Perry and I along with the F.E.M.A. group continued the process of documenting the roads damaged by Tropical Storm "DEB" back in August. We now have the first seven damaged roads identified with a F.E.M.A. project

number. All the paperwork for these roads should be completed and submitted by 2/7/25. A check should follow in approximately six weeks.

2/6/25 I received the I.D.A. Pilot Assessment spread sheet for Prattsburgh regarding the Terra-Gen Project. The I.D.A.has having a cost analysis by an outside firm. Once the numbers are

confirmed Jamie Johnson will attend our board meeting to explain. This will probably be scheduled for the March meeting.

2/7/25 Angela and I met with Chris Costanza to discuss his plans with the Main Street project. Chris informed us that he still hasn't received any quotes to replace the water lines in the building or the alarm system. Chris Costanza told us that he was going to update the prints complying with the New State ruling in the next couple of weeks. When the town receives the updated drawings, Chris Whipple will review.

2/11/25 John and I had our weekly meeting with the F.E.M.A. group. The goal was to arrange groups of roads that need repair and or mitigation then assign a project number for that group to be approved by F.E.M.A. So far, we have three project numbers that include eleven roads.
